

## Bristol and West AC Privacy and Data Protection Notice for Members

Bristol and West AC (**Club**) are committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, Bristol and West AC is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way. This policy was last updated in May 2018. In addition to this document please also see the Club's Privacy and Data Protection Policy, which is available from the Club's website.

### **What personal data we hold on you**

You may give us information about you by filling in forms at an event, online, or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with the Club, subscribe to our newsletter or social media pages. The information you give us may include your name, date of birth, address, e-mail address, phone number, name of the EA affiliated Clubs with which you are registered and gender (Athletics Data). We may also ask for relevant health information, which is classed as special category personal data.

### **Why we need your personal data**

The reason we need your Athletics Data is to be able to administer your membership and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

#### **For training and competition entry**

- sharing personal data with club coaches or officials to administer training sessions
- sharing personal data with club team managers to enter events
- sharing personal data with facility providers to manage access to the track or check delivery standards
- sharing personal data with leagues, county associations (and county schools' associations) and other competition providers for entry in events.

#### **For funding and reporting purposes**

- sharing anonymised data with a funding partner as condition of grant funding e.g. Local Authority
- analysing anonymised data to monitor club trends
- sending an annual club survey to improve your experience as a club member

#### **For membership and club management**

- processing of membership forms and payments
- sharing data with committee members, e.g. to provide information about club activities, membership renewals or invitation to social events
- club newsletter promoting club activity

- publishing of race and competition results

Any special category health data we hold on you is only processed for the purpose(s) of passing health data to coaches to allow the safe running of training sessions. We process this data on the lawful basis of consent. Therefore, we will also need your explicit consent to process this data, which we will ask for at the point of collecting it.

The club has the following social media pages: Facebook, Twitter. All members are free to join these pages. If you join one of the Social Media pages, please note that providers of the social media platform(s) have their own privacy policies and that the Club do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages.

### **Who we share your personal data with**

When you become a member of the Club, all Competing Members will be registered as a member of England Athletics Limited. When Competing Members are registered as members of England Athletics Limited, we will provide England Athletics Limited with your Athletics Data which they will use to enable access to the MyAthletics online portal. England Athletics Limited will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. If you have any questions about the continuing privacy of your personal data when it is shared with England Athletics Limited, please contact [dataprotection@englandathletics.org](mailto:dataprotection@englandathletics.org). Non-Competing Members data will not be shared with England Athletics Limited. Please be aware that should you ever wish to compete in your sport you will have to register with England Athletics Limited at that time.

The Club does not supply any personal data it holds to any other third party. The Club stores personal data in the membership database (PaySubsOnline), additionally individuals may opt-in to the mailing list (MailChimp). Except in those cases listed above the club does not store or transfer any personal data outside of the UK.

### **How long we hold your personal data**

We will hold your personal data on file for as long as you are a member with us. A full breakdown of the data we hold and how long it is kept before being securely destroyed is listed in the Club's Privacy Policy. Your data is not processed for any further purposes other than those detailed in this policy.

### **Your rights regarding your personal data**

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data.

As a data subject you are not obliged to share your personal data with the Club. If you choose not to share your personal data with us we may not be able to register or administer your membership.
